Upon the same principles, a limitation over of the annuity upon an indefinite failure of issue is void, as depending upon too remote a contingency. (*Ssalle v. Scale*, P1-ec. in Ch. 421. 1 P. The limitation over of the annuity to Mary Theresa is not upon an indefinite failure of issue, but upon the contingency of her dying without issue living at the time of her death. Therefore, upon the principle of the case of *Wilkes v. Lyon*, (2 Count, 333, ) she is entitled to the same in perpetuity; subject, however, to the contingency of her dying before the other grand daughters, and without issue living at the time of her death. And she is not entitled to the absolute control of the fund set apart for the purpose of raising that annuity, until it is ascertained that the limitation over cannot take place. The \$200 annuities to the other grand daughters are also in perpetuity, but the whole goes to the survivor, if either dies in the life time of the other without issue living at the time of her death. will is, that the executors take the whole estate, with power to sell the same for the purposes of the will; subject, however, to this restriction, that the widow is entitled to the.
